- Met with Mr Canini and Mr. Sica at CCS, and they are eager to help with youth program with transportation. They cannot bus to the new (old) school since its within walking distance – however, we will do an intermunicipal agreement for salt, which they need. Discussed possibilities of how we will cross level resources within village (salt comes from dpw, transportation in exchange goes to youth) based upon expenses.
- b. Youth meeting will meet on 11/16 at 7:00pm to discuss rec facility. Completion timeframe contractor thinks they can knock out the rehab work in 4-5 weeks once they get started. Mayor is looking to reassemble Youth Commission so that it is compliant as a commission. Val Reagan Lease was signed without exhibits. Mayor all exhibits must be in there prior to our occupancy. He has until March if items not complete, then contract is null and void. Val Reagan what standard is the building being renovated to? Mayor County standards.
- c. Academy Street speed ran speed radar for 3 weeks.... 15,678 cars. 5880 were speeding 30-35, 2000 35-40, 282 40-45, 32 45-50, 10 55-60. J Sweeney what about speed bumps, decoys, etc.... Chief recommends reduce speed on that street to 20. Patterson says no law necessary for speed, just for stop signs. Patterson says that anything lower than 25 needs to require a bit of work. Dropping to 20, he needs to do research. Will revisit in December.
- d. Jackson posted that they had PFOAs located in a private well next to the old dump. It was a low level non-detect. A few have tested within the village and are also coming up with trace amounts.
